(3) Trust Property:- The Trust Property shall comprise of the said initial Trust Fund as well as all other amounts, securities, properties movable or immovables, which may be contributed or donated by the Trustees, Members of the public or anyone else or from any other source and shall also include all additions accretions, and acquisitions made by the Trust and the income received by the Trust from time to time. Trust Property shall vest in the Trustees, herein upon Trust, subject to the provisions hereof for the due fulfilment of the objects of the Trust.


(4) Office of the Trust:- The principle office of the Trust shall at present be 9 Vedhachala Street, Arakkonam, Vellore N.A. District, Tamil Nadu State.

(5) Nature of the Trust:- This Trust shall be a Public Charitable Trust having no commercial or profit motives. It shall be maintained and administered to promote education, medical relief, running of the Kalyna Mantap, for the benefit of the weaker sections of public, a home for physically handicapped, a home for orphanage and any other objects of general public utility. The benefit of this Trust shall ensure to all sections of public in India without any distinction. The Trust Property including its funds and income shall be applied solely towards promotion of the objects for which this Trust is established.


(6) Objects of the Trust:-

a) To establish, found, organise, start, take over, promote, construct, run, expand, propagate, distribute, develop and improve:-

i. Religious institutions such as churches, seminaries, theological schools, colleges, Sunday schools, Gospel crusades, printing of tracts and religious literatures audio and video cassettes, meeting, spirit filled lives of men, women, youths and children, and observe Holy sacraments given by our Lord Jesus Christ.



ii. Educational Institutions such as elementary and primary schools, secondary and higher secondary schools, polytechnics, colleges, technical / vocational training institutions, residential schools etc., for students without distinction of caste, or religion.

iii. Orphanages, schools and homes for disabled and disadvantaged children, widows homes, homes for the aged, relief works and social welfare programmes among gypsies, hill tribes, lepers, eye sick people, community development and rehabilitation programmes and

iv. Missions, Trusts, Societies and Companies in any part of the country in any other name as the case warrents and carry on similar works as above and any other religious, social, medical and charitable activities as the Trust may deem fit.

b) To do all such other things that may be conducive or necessary for the advancement and the carrying out of the above objects and purposes of the Trust.

c) To accept, upon such terms as they shall think fit, any donations, grants, subscriptions, aid and contributions from any Government local authority corporation, firm, company, syndicate, associations, or other person or from any charitable or other institution or from any foreign agency whether they be in cash or in any other movable or immovable property for the purposes of the Trust PROVIDED ALWAYS that the terms upon which they shall be accepted shall not in any way be inconsistent with the repugnant to the provisions contained in these presents and such donations, grants, aids, subscription and contributions shall be applied for all or any of the objects of the Trust.

d) To borrow money for the purposes of the Trust upon any terms and conditions.

e) To do all such other lawful things as may be considered incidental or conducive to the attainment of the objects mentions above.

f) To receive grants from Agencies including Central Board for the Workers education to conduct programmes for rural Women.

g) To do such other activity / activities for furtherance of Art, Literature, Music etc.

(7) Management of the Trust:- This Trust shall be administered by a Board of Trustees whose Numbers shall not be less than two... or more than seven.

(8) Vacancies:- A Trustee shall cease to be in office with immediate effect with his becoming insolvent or insane or of on being convicted of any offences involving moral turpitude or at resignation or the case of a Trustee who is also employed by the Trust who fails in meeting the standard of work expected of them by their employer. Any vacancy occurring in the office of Trustees shall be filled by the other Trustees either unanimously or with the consent of the majority. The existence of vacancies in the office of the Trustees shall not invalidate any act or decision by the Board of Trustees.

(9) The Trustees may from time to time delegate to any one of them or to another person or Committee, such of their powers and duties as they deem fit, subject to, nevertheless to, their retaining the ultimate control and supervision.

(10) Power of Trustees:- Trustees shall have full power and authority to administer the Trust Property. The investments shall be in accordance with the provisions of sections 11 - 13 of the Income Tax Act.

a) To receive, collect and enforce recovery of all monies due or payable to the Trust and grant necessary receipts and discharge therefore.

b) To appoint, terminate, suspend and otherwise deal with employees.

c) To appeal and act before courts, tribunals, public offices, etc.

d) To institute, prosecute and defend all suits and other legal proceedings.

- e) To incur all necessary expenses from the corpus or income of the Trust in connection with the Trust and its management and for its institutions.
- f) To apply properties and funds of the Trust for the objects of the Trust.
- g) Generally to do all such acts, deeds and funds as may be required to fulfil the purposes of the Trust and matters incidental thereto.

(11) Transaction of business by the Trustees:- The Trustees shall meet once in three months or as often as may be necessary for the efficient conduct of the affairs of the Trust. Such meetings shall be presided over by the Chairman of the Trust or in his absence or inability, by one the Trustees elected by the Trustees to be the Chairman of the meeting. The business of the Trust may also be transacted by circulation of papers. All decisions of the Trust will be by a simple majority except as otherwise expressly provided therein. The Chairman of the meeting shall be entitled to a casting vote in event of equality of votes at the meeting.

(12) The accounts and minutes:- The Trustees shall maintain true and correct accounts for all receipts and payments and dealings with regard to Trust property and shall also maintain the correct record of the meeting and deliberations.

(13) Indemnity:- The Trustees shall be fully kept indemnified and harmless by the Trust against any action or claim, loss suffered or liability arising against them on account of anything done by them in good faith pursuant to the powers and authority conferred on them by these presents.

(14) Irrevocability / Amendments of the Trust:- The provisions of this Trust may be altered or amended by the resolution passed by the Board of Trustees either unanimously or with the consent of the 3/4 majority provided the character of this Trust as a charitable Trust for the promotion of the objects set forth above shall not be altered.

(15) Provisions of determination of the Trust:- In the event of the determination of the Trust or if this Trust should fall in any reason the Trustees shall make over or transfer the funds and properties of this Trust to any other Trust or Institution having objects generally similar to those of this Trust and donations to which are exempt under Section 80 - G of the Income Tax Act, 1961, if the resolution to that effect is passed by the Trustees unanimously or by not less than three-fourth majority.
